उक्त के क्रम में पत्रांक उ0चि0से0च0बो0/परी0(स्वा0कार्य0)/12/2021-22/868, दिनांक 15 नवम्बर, 2022 के माध्यम से अभ्यर्थियों द्वारा आवेदन पत्र के माध्यम से उपलब्ध कराये गए डाटा का परीक्षण के पश्चात् कतिपय अभ्यर्थियों को अर्हता पूर्ण न करने एवं गलत आवेदन करने के कारण से अनर्ह घोषित कर दिया गया। चयन बोर्ड कार्यालय के पत्र संख्या उ0चि0से0च0बो0/परी0(स्वा0कार्य0)/12/2021-22/873, दिनांक 16 नवम्बर, 2022 के माध्यम से चिकित्सा स्वास्थ्य एवं परिवार कल्याण विभाग, उत्तराखण्ड में समूह 'ग' के अन्तर्गत स्वास्थ्य कार्यकर्ता (महिला) के रिक्त 824 पदों पर बैचवार श्रेष्ठता क्रम में बोर्ड द्वारा निर्धारित मानकों के आधार पर अभ्यर्थियों को दिनांक 30 नवम्बर, 2022 से दिनांक 20 दिसम्बर, 2022 तक रिक्तियों की संख्या लगभग दो गुना अभ्यर्थियों को अभिलेख सत्यापन हेतु आमंत्रित किया गया। अभिलेख सत्यापन में कुल 28 अभ्यर्थियों को मा0 उच्च न्यायालय उत्तराखण्ड नैनीताल में दायर विभिन्न रिट याचिकाओं के आदेशानुसार औपबधिक रूप से अभिलेख सत्यापन में सम्मिलित किया गया तथा मा0 उच्च न्यायालय उत्तराखण्ड, नैनीताल में दायर एक रिट याचिका में एक अभ्यर्थी हेतु पद रिक्त रखने के लिए अन्तरिम आदेश पारित किये गये हैं।
